#### **SUMMARY**

#### PROJECT DESCRIPTION:

ADOT is about to embark on a major improvement program for I-10 between Verrado Way and SR85, which will include widening the freeway and completely rebuilding the Watson and Miller interchanges. While this work is long overdue and the community will benefit long term from the improvements, during the construction period there will be direct impacts to the community in terms of ramp closures, reduced traffic capacity, and traffic restrictions, which are likely to cause hardships on the local business community.

Staff has been developing a comprehensive plan to help mitigate the impacts of the construction, which will be discussed with Council. Possible components of this plan include:

- Enhanced signage: This could include renting additional signage on the freeway to insure drivers are aware of detours, enhanced detour wayfinding signage on local streets, etc.
- Enhanced Communication: Additional regular communication through multiple methods (i.e. social media, website, ads, utility bill inserts) to local businesses about upcoming closures and other traffic disruptions, as well as to residents about closures and alternative routes to businesses
- Temporarily relaxed development standards: Allowing restaurants to have additional outdoor dining (as we have done for the pandemic), and allowing businesses to have additional banners or sandwich board signs near the street to better let customers know they are open
- A "Shop Buckeye" program: A program, in conjunction with the Buckeye Chamber, to promote all local businesses to the residents, which could include weekly drawings for cash prizes for residents who submit receipts from local businesses. There could be additional incentives offered for shopping in downtown Buckeye.
- Business Tool Kit: Regular in person/virtual meetings or info sent to businesses with ideas on promotions, discounts, and other techniques to attract more customers. Can also include store window decals, customized videos or graphics, etc.
- Other programs that may be utilized from time to time

Staff would like to gauge level of interest from the Council in these ideas, as well as soliciting other ideas, in order to put together a comprehensive program and ultimately seek Council authorization.

#### **BENEFITS:**

This program will assist the local business community during the I-10 construction by helping to mitigate the expected impacts. This would also benefit the City which could see decreased tax revenues if businesses are impacted.

**FUTURE ACTION:** Council and staff; does this need to be communicated internally/externally? Staff will develop a final comprehensive program and bring this back to the Council for approval, likely in April.

#### FINANCIAL IMPACT STATEMENT: Must be completed before submission

Unknown at this time; this will depend on the extent and duration of the programs desired by Council. Communications and Economic Development both have some monies in their current year budgets that can be contributed towards this effort.

Full closure of the I-10 Eastbound and I-10 Westbound mainlines will not be allowed.

The contractor shall maintain at least one lane in each direction on I-10 at all times.

No rolling closure to transfer any equipment or perform any work will be allowed at any time unless otherwise approved by the Engineer.

The contractor shall maintain at least one lane in each direction on Miller Road and Watson Road, except as specified below.

The contractor may reduce Miller Road north of the Miller Road TI to one lane, two-way operation utilizing temporary traffic signals or flaggers. Full closure of Miller Road north of the Miller Road TI will not be allowed.

Short-term closures at the Watson Road TI will not be allowed simultaneously with short-term and long-term closures at the Miller Road TI.

Short-term closures at the Miller Road TI will not be allowed simultaneously with short-term and long-term closures at the Watson Road TI.

Short-term closures shall be subject to liquidated damages assessed at 15-minute intervals as specified below in Table 104-4.

<sup>\*</sup>Both ramps shall be constructed simultaneously within one consecutive long-term closure. Both ramps shall be fully opened to traffic to be eligible for the incentives as specified in Subsection 104.04(F)(7) of the specifications.

Only one consecutive long-term closure will be allowed for each location.

Only one long term closure shall be active at any given time; simultaneous long-term closures will not be allowed.

Long-term ramp closures will not be allowed during long-term crossroad closures.

The contractor shall not perform any work at SR-85 until all lanes and ramps at the Miller Road TI are open in their final configuration.

Long-term closures shall be subject to incentives and liquidated damages assessed at daily intervals per Subsection 104.04(F)(6) of the specifications.

The allowable durations specified in this table shall not be changed. If the contractor completes an activity in less than the specified duration provided in this table, the number of days saved shall not be used to extend the allowable duration of any other closures.

# Economic Development, Signage, and Business Support



### Potential Economic Impacts

- During major construction projects, the impact to businesses can be significant
- During ramp closures and other disruptions, typical patterns of business can be disrupted
- It can be especially difficult for businesses who rely on driveby freeway traffic – hotels, restaurants, gas stations, etc.
- This could be even worse in Buckeye as alternative exit and entrance ramps to the freeway are 2-3 miles away
- This can also have a significant impact to the City finances just a 5% decline in retail sales would translate into the loss of \$2 million in City revenues

### **Information is Critical**

- In looking at other areas that have experienced significant construction impacts, the number 1 recommendation is that <u>INFORMATION</u> is critical
- There are many ways to get the word out about closures
- We will talk shortly about how we will get information out to the residents and businesses
- For highway travelers and visitors the best way to let them know about closures is with freeway messaging signs

# Portable Vehicle Messaging Signs







### Freeway Signage

- ADOT will place temporary VMS to notify motorists about upcoming closures, but those will be fairly generic i.e. "Watson exit closed 9p-5a"
- One way the City could assist is by renting additional VMS signs and adding more detail:
  - "Watson closed, for hotels, gas, food, detour via Miller"
- Two additional signs in each direction would cost about \$80,000 per year.
- Another option would be renting private electronic billboards along the freeway

## **Local Signage**

- In addition, we believe that enhancing signage on local streets will also be important
- As travelers detour off of the freeway, they need to have frequent and consistent signage directing them. This could also be beneficial for locals who don't typically use the alternative streets.
- In order to stand out, we believe the signs will need to be different than usual City signs more colorful, larger, etc.

### **Business Tool Kit**

- We also think a "Business ToolKit" could be of assistance to local businesses
  - Marketing suggestions
  - Ideas on promotions and special events
  - How to use social media to promote your business
  - Business seminars or training
  - Information about additional temporary signage
  - Decals and signs
- Could be done by a consultant under contract to City

### **Direct Business Outreach**

- Partnering with Chamber
  - Assist with providing consistent info to businesses
  - Business Kits marketing materials, etc.
  - Encourage businesses to offer special discounts or sales during construction
- Specific messages catered for:
  - Miller Road
  - Watson Road
  - Downtown



### **Business Outreach**

Work with Chamber to assist businesses with:

- Customized videos, graphic design and marketing ideas
- Connect with specific industries
  - Transportation/Trucking
  - Major Employers

City will also reach out to churches, schools, HOAs, etc.







### Outreach to Residents

- Provide frequent, consistent messages on construction
  - Sharing ADOT content
  - Social media/e-newsletters
  - Videos



- Encourage residents to shop local
  - Direct them to Chamber web pages for specials and discounts
  - Explain benefits of shopping local
- Promote "Shop Buckeye" campaign

Support businesses during construction by encouraging residents to shop local

 Direct residents to Chamber website for promotions, discounts and incentives from businesses

### Temporary Regulatory Relief Options

There could be some temporary relief granted to our normal development standards, such as:

 Additional signage: Allowing additional signs such as "We Are Open" banners on buildings, or allowing the use of sandwich boards along the street

- The ability for restaurants to have additional outdoor dining areas (as we have done during the pandemic)
- Streamlined and/or no cost approval process

### <u>Summary</u>

- A comprehensive program is the best way to minimize any potential impacts of the freeway construction
- We know there are certain things we can't do, such as:
  - Advertise specific businesses on freeway signage
  - Write a check to a business to cover losses
- Some of these items will have specific costs associated with them, while some are simply staff time
- Both E.D. and Communications have some money in our budgets to assist with these costs, but depending on the extent of desired activities we might need contingency
- Plan is to come back to council for formal action 4/6
