#### **SUMMARY**

#### PROJECT DESCRIPTION:

The Arizona Department of Transportation is proposing a roadway widening project on Interstate 10 from approximately milepost 111.7 (State Route 85) to milepost 122.8 (Perryville Road). ADOT will construct a single general purpose lane in the median in both east and westbound travel directions.

In addition, improvements will be made to the traffic interchanges of Watson and Miller roads include widening both streets to a minimum of two lanes in each direction, dedicated turn lanes, storm drain improvements, noise barriers (if needed after a noise analysis is conducted), lighting, signage and roadway striping and restriping. ADOT will also explain the diverging diamond interchange design being considered for this project.

### **Project Overview**

- Additional lane on I-10 between SR 85 and Verrado Way
- Reconstruct traffic interchanges at Miller and Watson roads
- Construction programmed in spring 2020





### **Traffic Analysis and Results**

- ▶ Traffic Volumes
  - Significant congestion anticipated by 2040 without I-10 widening
  - I-10 can handle anticipated traffic with additional lane
  - Improvements needed at Miller and Watson road interchanges











